



**MEMBER ORGANIZATIONS**  
**UKRAINIAN CANADIAN CONGRESS**  
**TORONTO BRANCH**  
**as per corporate bylaws**

**CRITERIA**

The UCC - Toronto Branch shall consist of Ukrainian Canadian organizations, associations, and clubs (herein Member Organizations):

- a. whose activities are aligned with the purpose and objectives of the UCC – Toronto Branch;
- b. who are located in the Greater Toronto Area; or in surrounding municipalities where no other UCC branch exists to serve their needs; and
- c. who apply and are accepted as members.

**CATEGORIES**

Member Organizations shall be classified, as described in the chart below, into one of three categories according to their membership, which will establish:

- a. the maximum number of delegates eligible to represent the Member Organization at UCC – Toronto Branch General Meetings, and
- b. the Member Organization's annual membership fee.

MEMBER ORGANIZATION CATEGORIES			
Category	Membership	Maximum no. of Delegates	Annual Dues
A	10 or fewer	1	\$ 50
B	11 – 50	2	\$100
C	51 – 100	3	\$150
D	More than 100	4	\$300

**DELEGATES**

- a. May represent only a single Member Organization at UCC – Toronto Branch General Meetings; and
- b. May be elected to the UCC – Toronto Branch Executive, Board, or Audit Committee.

## **MEMBERSHIP ADMISSION**

Organizations, associations, and clubs applying for membership shall fulfill the following conditions:

- a. declare in writing their intention to join; and
- b. submit their objects, constitution and by-laws, names of board members, number of members, and furnish information concerning the activities of their organization.

Only those organizations, associations and clubs who adhere to the principles of equality and democracy and whose applications are approved by two-thirds (2/3) majority of the votes cast by the Board shall become Member Organizations.

## **MEMBERSHIP TERMINATION**

The Board may terminate, by two-thirds (2/3) majority of the votes cast, the membership of any Member Organization for just cause. Such termination and application may be appealed to the next General Meeting, by two-thirds (2/3) majority of the votes cast.

The Executive may, at any future date upon written notice, request a copy of any Member Organization's membership list, names of board members, constitution and by-laws, or other relevant materials to ensure the Member Organization's continued compliance with the UCC – Toronto Branch By-laws.

## **FEES**

Member Organizations shall pay to the UCC – Toronto Branch an annual membership fee approved by the Bi-annual General Meeting and communicated in writing to each Member Organization.

Membership fees are due at the start of each UCC – Toronto Branch fiscal year.

In the event of non-payment of membership fees for a period of two (2) years, the Member Organization ceases to be a Member Organization at the expiration of a period of one hundred and eighty (180) days following the receipt of a registered written notice from the Executive advising the Member Organization of such default.
